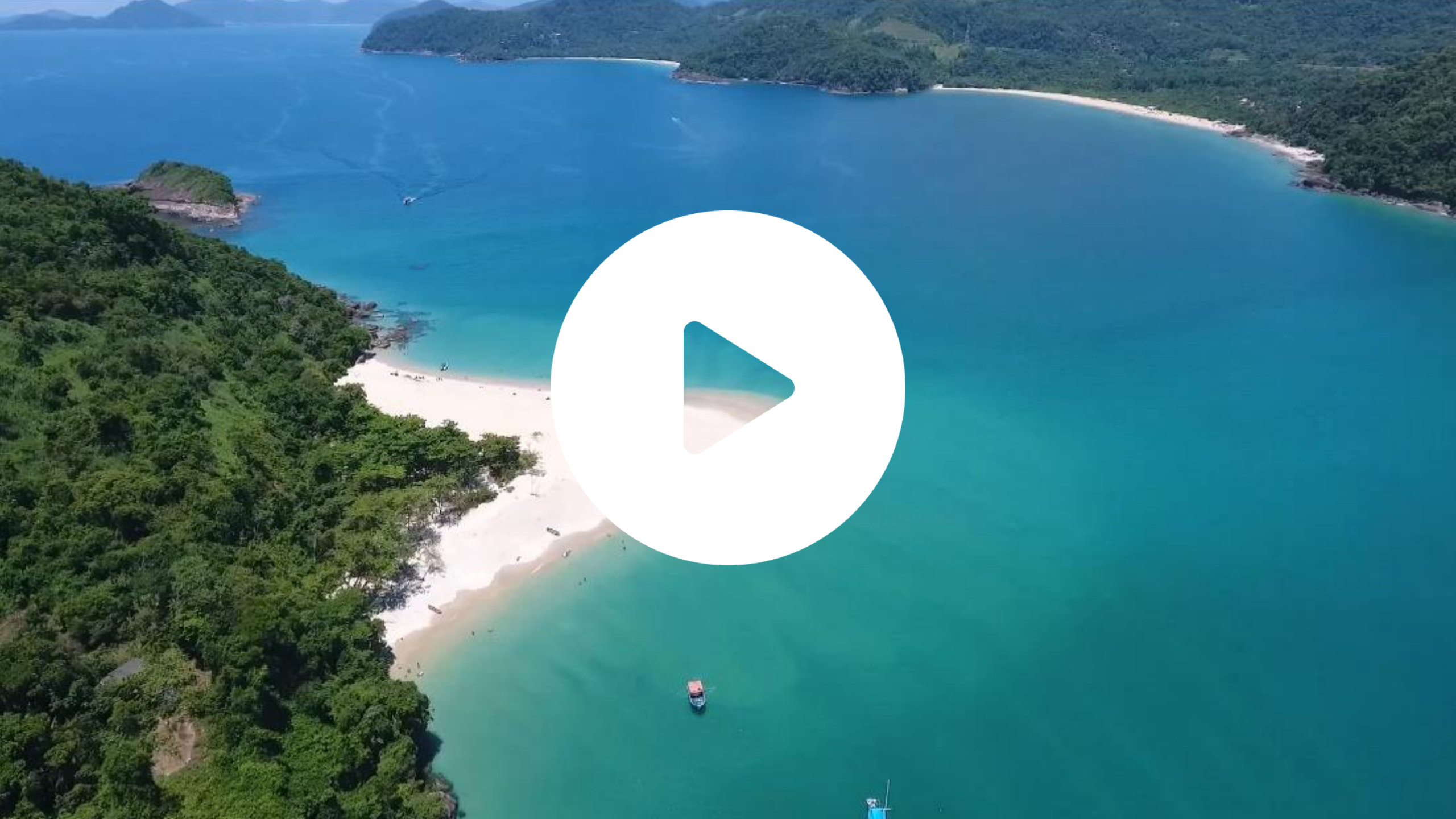
COP In BRAZIL

Our objective is to share experiences and develop concrete proposals to combat climate change and defend biodiversity, taking as a guide the practices of territories protected by indigenous villages, caiçara communities, riverside communities, extractivists, quilombolas, and all those who work to defend our biomes.

REALIZATION

The Seminar will be promoted by the Observatory of Sustainable and Healthy Territories of Bocaina (OTSS)*, an initiative that arises from the partnership between the social movement Forum of Traditional Communities of Angra dos Reis, Paraty and Ubatuba (FCT) and Oswaldo Cruz Foundation (Fiocruz).

The OTSS was created with the aim of expanding and qualifying sustainable development in the traditional territories of Bocaina, a region that is home to more than 150 communities including Caiçaras, Indigenous Peoples and Quilombolas.

The program is based on the territorial assessment and monitoring of the UN Agenda 2030 Sustainable Development Goals Program.



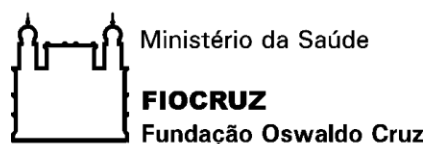

ECOLOGY OF KNOWLEDGE FOR GOOD LIVING

Thematic block that aims to design political strategies to promote Good Living and Climate Justice. We will identify potentialities and challenges faced by **Traditional Communities** in implementing the 2030 Agenda, in addition to discussing their role in Conservation Units and in the management of territories.

RESILIENCE STRATEGIES TO HEALTH & CLIMATE EMERGENCIES

Theme that will discuss the implementation of the National Health Policy for Rural, Forest and Water Populations.

The objectives are to make sensitive socio-environmental circumstances visible and identify strategies adopted by traditional and vulnerable communities in facing multiple risks, with a sensitive eye on environmental racism, structuring in these areas.

- Actions to combat and manage socio-environmental disaster risks.

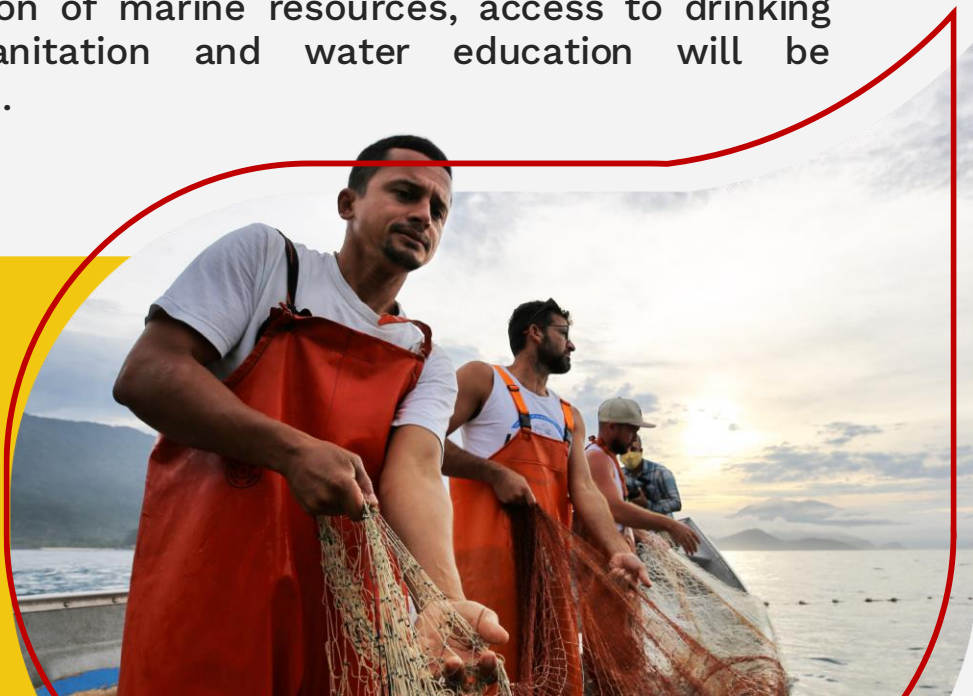

OCEANS & RIVERS NETWORKS OF LIFE & KNOWLEDGES

Thematic block that seeks to build an agenda for the defense of continental and maritime waters, strengthening the **solidarity economy and food security**. To achieve these objectives, topics such as artisanal fishing in Latin America, sustainability strategies, preservation of marine resources, access to drinking water, sanitation and water education will be addressed.

- Access to safe drinking water, sanitation, water education and promotion of life.
- Women from the countryside and waters in promoting the solidarity economy.

AGENDA

EDUCATION, CULTURE & WAYS OF LIVING

The thematic block seeks to value differentiated education and cultural expressions, promote sustainability and guarantee respect for Traditional Territories. To achieve this, we will build an agenda around three central themes: the role of **environmental education** in conserving the biodiversity of traditional ways of living; the defense of the territory as a strategy to **preserve material and intangible heritage**; and the organization of community networks in community-based tourism, boosting autonomy and income.

- Defense of the territory as a strategy for preserving traditional communities.
